Fund Manager Comment

Market Performance

Equity markets continued to rebound strongly during March, the combination of improving macroeconomic data and burgeoning risk appetite leaving most indices close to new eighteen month highs, the FTSE World Index rising 6.6% in Sterling terms during the month. Whilst risks associated with Chinese policy tightening and economic challenges faced by Greece and Portugal have not been entirely resolved, fears have subsided allowing investors to focus on the strong earnings reports and improving macro economic data (including US employment, ISM and consumer confidence reports). Oil prices and US bond yields rallied as a result of improving fundamentals but also in the latter case, this was also due to an increased supply of US government debt. Small caps continued to outperform during the month, likely reflecting an increased risk appetite and lower exposure to the FX headwinds represented by a stronger US Dollar.

Sector performance

Whilst March is typically a quiet month in what is empirically the softest quarter of the year for technology companies, 2010 has been atypical with tight inventory levels and steadily improving demand combining to produce better than seasonal trends which saw the sector outpace the broader market during the month, the Dow Jones World Technology index rising 7.2% in Sterling terms. Semiconductor stocks were amongst the best performers propelled by positive updates from amongst others Qualcomm, Avnet, Applied Materials and Microchip. Demand for enterprise software also appears to be improving, evidenced by encouraging off-quarter reports from the likes of Adobe, Oracle and Red Hat. Apple was also a strong performer ahead of the launch of its new iPad whilst the only real disappointments came from Research in Motion and Palm, both due to what appear to be stock specific reasons. It is also worth noting, there have been a number of recent debt/convertible or equity offerings from stocks with already strong balance sheets (including Salesforce.com, Concur, SAP, Autonomy and Adobe) indicating that although M&A activity has been surprisingly quiet year to date, that may be about to change.

Outlook

First quarter earnings season gets underway next week with industry bellwethers such as Intel, ASML and Google likely to set the early tone. Based on our recent upbeat company meetings and trips combined with numerous positive pre-announcements we expect results generally to come in towards the high end of expectations driving further earnings upgrades whilst improving visibility is likely to drive solid second quarter guidance. Extending lead times will undoubtedly have led to some instances of double ordering but there is little evidence that this is widespread and we expect inventory levels to exit the quarter at healthy levels. That said, given the recent sector and market strength we might see investors 'sell the good news'. If so, we would regard any weakness not based on fundamental disappointment as a buying opportunity for longer term investors. This view is supported by our belief that there is finally a new technology cycle unfolding that should disproportionately benefit next generation companies unencumbered by legacy exposure. With the global technology sector trading at just an 11% PE premium to the S&P (source: UBS) before its net cash position is considered, this suggests that any relative setback should be modest.

Approach

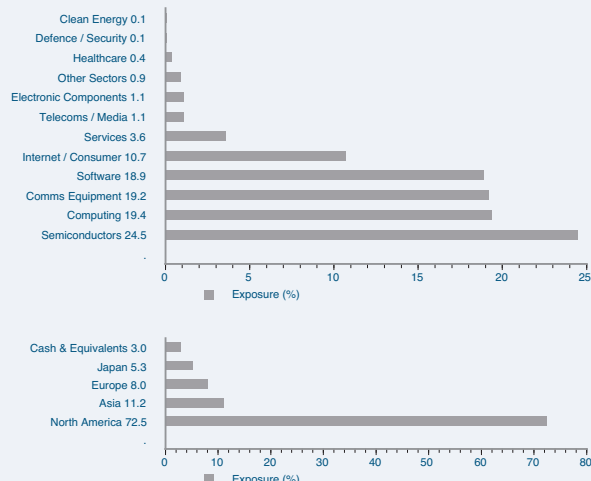

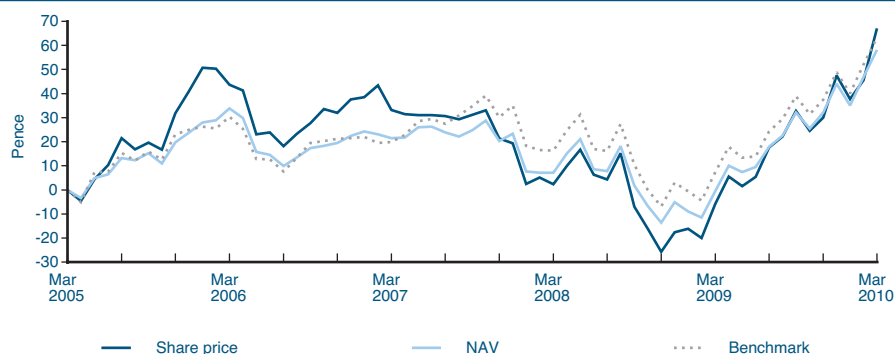

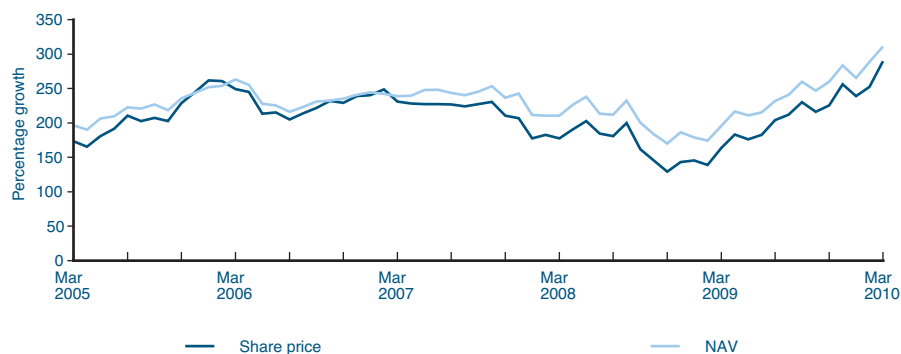
