Fund Manager Comment

Market review

Equities rallied strongly during the month, the FTSE World index rising 4.4% in Sterling terms. Whilst macroeconomic data was mixed, US Dollar weakness provided a supportive backdrop for equities and presaged the outperformance of large cap stocks. Risk appetite was further underpinned by positive rhetoric emerging from the G20 and comments from US Fed Chairman who reiterated that interest rates would remain 'exceptionally low' for an 'extended period'. The only real test for markets came close to month end when Dubai debt default fears rattled investors driving up risk aversion and initiating a brief flight to quality ahead of Thanksgiving. However investors chose to refocus on the Bank of America TARP repayment plan and a favorable November employment report rather than worry about the financial travails of a small, profligate and oil-poor Emirate.

Technology review

The technology sector performed broadly in line with the overall market, the Dow Jones World Technology index rising 4.2% in Sterling terms during the month. With third quarter earnings season largely completed during October, there were limited 'bottom-up' developments during the month. That said the clear divergence of fortunes between incumbent and next-generation companies was evident from off-quarter reports during the month, with strong results from Salesforce.com and encouraging commentary from Cisco in contrast to disappointing earnings from both Dell and Autodesk. With 2010 IT budget growth likely to prove underwhelming this bifurcation should persist the need to 'do more with less' forcing the adoption of disruptive new technologies that in aggregate form the basis of a new cycle. This is also driving a wave of M&A which we expect to gather pace during 2010 as incumbents use their legacy 'free' cash flows to remain pertinent and retain a growth facade.

Outlook

Given strong year to date market and sector performance, periods of profit taking and increased volatility are almost inevitable. Despite this, the backdrop for equities appears constructive with the economic outlook stabilising, interest rates low and little evidence thus far of inflationary pressure. Technology has demonstrated clear leadership so far in 2009 and we are hopeful that this will continue into 2010 as the sector offers an almost unique mix of secular growth potential, balance sheet strength and valuation support.

Near-term fundamentals also appear in good shape with two members of the team having just returned from the US last week armed with evidence of ongoing improvement in fundamentals that suggest earnings in both 4Q09/1Q10 could be better than seasonal. This, combined with easier year-over-year comparisons, and currency tailwinds leaves us encouraged by the sector's prospects. However with third quarter earnings season witnessing a parting of ways between 'new cycle beneficiaries' and 'legacy incumbents' we suspect that the next phase of sector outperformance may be more stealthy as market-cap weighted indices prove poor proxies for the new cycle that is finally unfolding.




