Fund Manager Comment

Market Performance

The FTSE World Index fell 2.8% in Sterling terms during the period as the traditionally quiet summer months lived up to their reputation, bringing to an end the recent surge in equity markets. A quiet run-up to second quarter earnings season meant that top-down developments dominated the headlines as the market grappled for direction. Positive employment data (strong non-farm payrolls), and repayment of \$68bn of TARP funds by ten US financial institutions was offset by more mixed data elsewhere together with cautious FOMC commentary that accompanied the decision to leave interest rates unchanged. This weighed on the so-called 'reflation trade' resulting in lower inflation crossovers and modest profit taking in equities.

Technology Performance

The Technology sector regained its leadership status after a brief sojourn, the Dow Jones World Technology Index rising 0.6% in Sterling terms. Growth outperformed relative to value whilst small and mid caps outpaced larger issues. Semiconductors generated much of the sector news flow driven by improving fundamentals with industry leaders Texas Instruments and Qualcomm raising second quarter guidance early during the month. In total more than fifteen semiconductor companies positively pre-announced second quarter earnings. Unfortunately this did not translate into sector outperformance, as inventory restocking had been anticipated. The under-performance of semiconductor / cyclical sub-sectors no doubt contributed to the relative weakness of Taiwanese and Korean stocks.

Elsewhere, news flow in the technology sector remained remarkably quiet, reflecting an uneventful pre-announcement season. Oracle reported solid earnings and increased guidance indicating they had seen some pick up in business activity. M&A showed further signs of life with Intel offering to acquire Wind River (embedded software), Netlogic buying RMI (private semiconductor company) and both EMC and Network Appliance locked in a battle to acquire Data Domain. We anticipate further M&A as the economy stabilises and incumbents that are increasingly encroaching on each others traditional markets seek to stake out their claims.

Outlook

The upcoming earnings season is likely to set the tone for the next few months – we believe results will be generally solid given expectations were set at a low level in April. Limited visibility into second half demand is, however, likely to result in management issuing conservative guidance. This could result in a minor correction or a period of consolidation which we believe would be healthy, particularly if expectations for the second half are then set at realistic levels. If the economic recovery continues, companies are likely to increase (or release) their IT budgets over the latter half of 2009, resulting in a real improvement in demand and driving further positive earnings revisions. In the meantime, however, we have taken profits in a number of non-core cyclical stocks that have performed strongly from lows.

Whilst mindful of how well our sector has performed recently, we believe that investors have thus far embraced technology stocks due to their cyclical nature and balance sheet strength. We would contend that the secular story - one we have been articulating for several years - remains poorly understood. As such we expect the sector's new found leadership status to persist over the medium term due to its lack of participation during the last market cycle, a superior growth and balance sheet profile together with the unfolding of a new technology cycle.

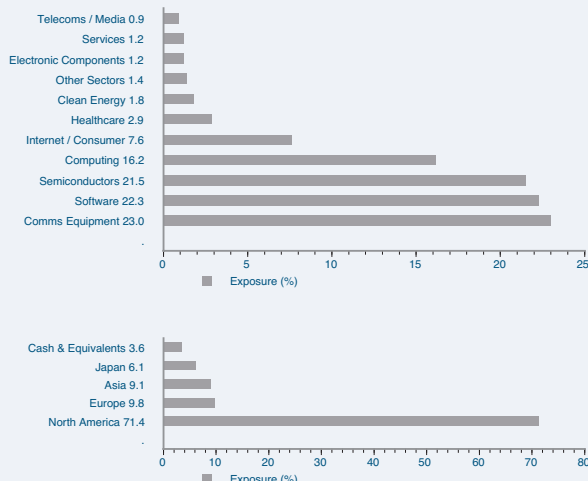
Approach

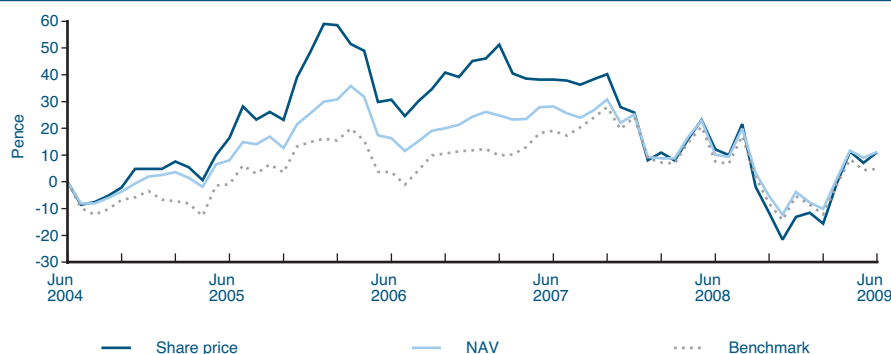
