Fund Manager Comment

Market review

October saw equity markets extend their recent gains, the FTSE World rising 2.0% in Sterling (GBP) terms during the month. Weaker than expected US consumer confidence and employment data was overshadowed by expectations that a further round of quantitative easing would soon commence made clear by Fed Chairman Bernanke's remark that "there appears to be a case for further action". The prospect of 'QE2' led to significant US Dollar weakness (which hampered Sterling returns) and further pressured US Treasury yields. However, with the so-called 'Fed put' back in place, risk appetite soared, aided by a third quarter earnings season that came in ahead of expectations.

Technology review

Having lagged the broader market recently, technology sector outperformance resumed during October with the Dow Jones World Tech index rising 3.3% in Sterling terms. Asian indices trailed, whilst Internet related stocks outperformed driven by robust earnings and guidance, including exceptionally strong results from Google. Elsewhere technology earnings were generally robust with "new cycle" beneficiaries such as Juniper, RightNow, and F5 Networks posting impressive quarters. In contrast, incumbents such as SAP, IBM and Nokia delivered more pedestrian performance. Semiconductor stocks, especially those in the consumer PC or LCD TV food chain, were the main area of fundamental weakness but the current inventory correction was largely anticipated by investors reflected by positive stock action.

Outlook

Whilst our base case remains unchanged - a prolonger period of sub-trend global growth looks inevitable - 'QE2' may be the 'new news' that allows stocks to break out of their 2010 ranges. Although we are mindful of continuing poor data and investor sentiment that is bordering ebullient, the 'Fed put' feels firmly in place which should limit downside from current levels. Whilst this reflationary backstop may take reduce some of the lustre associated with our new cycle names (as all stocks enjoy a liquidity related revaluation), we continue to believe that the kernel of our story - the recentralisation of computing - is entering the "sweet spot", reflected by copious amounts of interest in all things 'cloud'. However, limited growth in IT budgets make plain the predicament faced by large-cap incumbents who have limited footprint in these new disruptive technologies whilst needing to defend their traditional turf in enterprise computing. As such we believe that the first phase of sector outperformance that occurred post the late 2008 lows, is giving way to a more stealthy technology bull market, characterised by small and mid-cap outperformance.

Approach






